COVID-19 Waiver and Assumption of Risk

I also understand that such an exposure may result in illness or even death to myself, my dog, members of my family, or other members of my household. Additionally, I am aware that The Clever Canine, LLC offers physically distant teleconsulting services.

Despite this aforementioned risk and availability of alternative teleconsulting services, I choose to participate in in-person dog training classes and in-person private dog training lessons offered by The Clever Canine, LLC and will thus agree to observe, respect, and practice the following precautionary measures to limit transmission of SARS-CoV-2:

1. All trainers and volunteers will wear a face mask, or follow current recommendations.
2. Hand sanitizing measures will be taken, either by washing hands or utilizing hand sanitizer.
3. Handles and equipment used will be wiped down with disinfectant wipes.
4. A minimum of six feet of distance will be maintained between all participants when deemed necessary.
5. Participants are required to wear masks, or follow current recommendations.
6. Interaction between dogs is limited when social distancing is advised.
7. Participants will remain in their car or outside until it is their time to come into the building.
8. If participants have experienced a fever, chills, muscle pain, sore throat, cough, shortness of breath, loss of sense of smell and/or taste, vomiting, and/or diarrhea in the last 14 days, they will not attend in-person services offered by The Clever Canine, LLC.
